#### Subject : <u>Delegation of Powers to Administrators in HUDA</u>

Please refer to the subject cited above.

At present field Administrators are competent to administratively approve the estimates upto 10.00 lacs and they are also competent to re-appropriate the budget upto Rs. 1.00 crore.

On the other side the Superintending Engineers have also been delegated the powers for allotment of works upto Rs.5.00 lacs without any condition and upto Rs.10.00 lacs if the allotment is within ceiling premium.

In order to execute the works of special repair of internal roads of the sectors speedily, it has been decided that the powers may be revised in respect of special repair of internal roads of the sectors with the condition given below:-

- 1. The power to administratively approve the estimate of special repair of internal roads are enhanced from Rs.10.00 lacs to Rs.20.00 lacs. Accordingly the powers of Superintending Engineers are revised to allot the works of special repair of internal roads from the existing powers of Rs.10.00 lacs to Rs.20.00 lacs.
- 2. The technical specification for the special repair of internal roads of the sectors will be circulated by the Engineer-in-Chief,

HUDA accordingly to which the estimate of special repair of internal roads will be prepared and executed.

3. One single estimate for one sector will be prepared and it will not be bifurcated. In case it exceeds the limit of Rs.20.00 lacs, it will be sent to Head Office for the approval of the competent authority.

- 2. Before exercising this power a certificate may be obtained from the XEN /SE concerned that this work has not been included in any other estimate so that no duplicacy in the approval of estimate of works occurs.

Please refer to this office Memo No.20559-615 dated 18.07.2005 vide which it was decided that there will be no change in the powers of Administrators to accord the administrative approval to the estimates upto Rs. 10.00 lacs subject to the extent of Budget provision and availability of funds in the price fixation of the scheme.

These powers were revised vide memo No 31534-37 dated 1.12.2005 in respect of special repair of internal roads of sector with the following conditions:-

The Authority in 96<sup>th</sup> meeting held on 29.12.2005 has approved the above said delegation of powers with the modification that the Zonal Administrators will be delegated powers upto Rs. 50.00 lacs against all approved works which are provided for in the budget and price fixation. Resultantly zonal Administrator will be comptent to administratively approve the estimate upto Rs.50.00 lacs against all approved works which are provided for in the budget and price fixation.
